practices are not making a loss by delivering a service. LMC members will continue to engage with stakeholders to campaign for this. General practice needs to speak with a unified voice to ensure that practices and patients' needs are considered in planning services at a borough and North Central London level.

Recent and current areas where LMC committee members are engaged At a borough level:

- Commissioning intentions/ PMS premium use in Haringey participating in discussions with the CCG to discuss extended access and other locally commissioned services to be available in Haringey.
- The LMC held a number of meetings with Haringey Public Health and have negotiated improved fees for LARC fitting and removal.
- Representatives attend Clinical Interface Meetings convened with each trust to improve secondary
 primary care communication with both Whittington Health and North Middlesex University Hospital
 Trust. Please send through any issues experienced with secondary care for raising at these meetings
 (see details below).
- Haringey PCN Clinical Director meetings.
- HealthWatch to discuss patients' access to GP services.
- One Voice Haringey representation with Federation and CD reps to feed into the developing ICS.

At a North Central London level

- Meetings with BEHMT in conjunction with Barnet and Enfield LMCs to discuss the eating disorder service and prescribing for CAMHS patients.
- North Central London review to develop a pan NCL long-term conditions LCS including lobbying to agree for a transitionary year before the new NCL LTC LCS is introduced to allow practices time to prepare.
- NCL Primary Care Commissioning Committee.
- NCL Interface Steering Group.
